

The Committee considers the reports by the Comptroller and Auditor General on resource accounts of departments that have exceeded the limits of expenditure authorised by the Assembly. In 2010-11 two departments incurred excess expenditure. The specific cases were: the Department for Social Development (DSD) incurred a resource excess of GBP10.2 million; and the Department of Culture, Arts and Leisure (DCAL) incurred a resource excess of GBP2.8million. On the basis of their examination, the Committee recommends that the Northern Ireland Assembly provides the necessary amounts by means of an Excess Vote.
